The 6th Step

In our Fourth and Fifth Steps, we revealed to ourselves, God, and another human being these defects of character we are willing to have removed.

In my Fourth Step, my sponsor asked me to also list all the assets of my character. for truly, none of us are totally defective. Then, later in the Sixth Step, to help remove the defects, work the assets to the best of my ability, and full time. This leaves little time to act out in my defects. We are entirely ready, we must do the work, God is with us for guidance.

Follows is a partial list of Assets followed by a Defect; you may add or change as it fits your need(s). Each Step is represented in this list.

Step 1; Admit vs. Deny. Step 2; Serentity vs. Insanity. Step 3; Willingness vs. Self Will. Step 4; Morals vs. Clueless. Step 5; Responsibility vs. Fear. Step 6; Assets vs. Defects. Step 7; Humility vs. Uselessness. Step 8; Meditation vs. Self will. Step 9; Amends vs. Revenge. Step 10; Act vs. Procrastinating. Step 11: Sobriety vs. Loneliness. Step 12; Spiritual vs. Chaotic.

We have come a long way from "... what we used to be like..." and the A.A. program of recovery has stood us well. We now know ourselves, our Higher Power, and other human beings better than we ever did. Now's the time to be ready to treat them right.

FLINT AREA UNITY COUNCIL AIMS AND PURPOSES

- 1. To promote Unity among Flint Area A...A., and harmony with Al-Anon and Ala-teen groups
- 2. To exchange group ideas.
- 3. The G.S.R.'s and Alternates shall act as trusted servants of their groups.
- 4. Each group shall be represented by a G.S.R. or Alternate. One vote per group shall be allowed in the determining matters of policy and action affecting the groups. (Committee persons are allowed one vote.)
- 5. To continue advancement of Twelve Step work and sponsorship.

6. To help financially any member group of this Council who needs help. A two-thirds majority vote will pass on any such loans which shall not be in excess of sixty days. 7. The Twelve Traditions and Twelve Concepts of

A.A. shall prevail at all times.

8. No monies will be spent or sent out of the Council area without a two-thirds majority vote of the groups that have paid into the council in the last three months. If they are not present they will be contacted for a vote on the issue within one week.

9. The Council will create service committees and be financially responsible for them.


