The 9th Step

"Made direct amends to such people where ever possible, except when to do so would injure them or others".

"Only through positive action can I remove the remains of guilt and shame brought on by alcohol."

Daily Reflections (18 August). Used with A.A.W.S. permission

Rising from "guilt and shame" (on these valid grounds – as opposed to the denial through which we used to continue in sin and vice) is crucial to the way forward – towards maturity and a virtuous life. We must believe this – and execute these amends. Action is required – but then action is also our salvation.

"The spiritual life is not a theory. We have to live it." Alcoholics Anonymous; page 83. Used with A.A.W.S. permission.

This point may be understood best if we consider our original intention: to improve our way of life. We know that living well demands a cultivation of spiritual health; now we accept that, as vitality of the spirit is essential to life, spiritual health itself depends on action. "The alcoholic is like a tornado roaring his way through the lives of others." Alcoholics Anonymous; page 82. Used with A.A.W.S. permission.

Having "made a decision" (in Step 3) "to turn our will and our lives over to the care of God," we are now bound to others – and to service, especially where injury has occurred; towards anyone injured by our own tempestuous behavior, moral sense demands a serious effort to make a substantial positive contribution.

For most, Step 9 requires intense determination – and faith – as it usually promises severe adversity. We must be ready "to take the full consequences of our past acts," Twelve Steps and Twelve Traditions; page 87. Used with A.A.W.S. permission.

We will intuitively know how to handle situations which used to baffle us.

We will suddenly realize that God is doing for us what we could not do for ourselves.

Many intergroup/central offices sell A.A. Conference-approved literature for the convenience of local groups. (This includes Grapevine/La Vina).

☐ In 1965 the GSC (Grapevine Service Committee) recommended "that the Grapevine use the services of area committees in promoting the sale of Grapevine at the group and individual level."

☐ A GSC recommendation in 1975 stated: "that delegates communicate with the publishers of AA newsletters in their areas, urging them to use Grapevine blurbs, discussion topics, or other notices about the Grapevine regularly in their newsletters."

☐ In 1978 the GSC recommended "that a Grapevine information table be made a regular feature at all conferences, conventions, and assemblies."

□ In 1979, the GSC recommended that Grapevine representatives recommend to their groups that they sponsor subscriptions, where possible, for institutions, treatment facilities, and professionals being "sponsored."

☐ In 1980 the GSC recommended: "that groups make every effort to introduce newcomers to the Grapevine as one of our best tools in sobriety."

☐ In 1988, the GSC recommended "that in order to encourage full participation, areas consider establishing a Grapevine awareness month and continue to hold Grapevine workshops, Grape-athons, and Grapevine meetings."
