A.A.W.S. and the A.A. Grapevine are both tenants of the Interchurch Center, 475 Riverside Drive and W. 120th St, NY, NY. 10115.

The Center was built from gifts of John D. Rockefeller, Jr. and other donors. More than 30,000 witnessed the Center's cornerstone as it was laid by President Dwight D. Eisenhower on October 12, 1958. The marble cornerstone is from the Agora in Corinth, Greece. Agora in Greek means 'open place of assembly'.

The 19 story building's simple architecture is intended to complement, not compete, (attraction rather than promotion) with the gothic architecture of surrounding buildings. It took 86 railroad cars to deliver Alabama white limestone for the building.

The CMIA 32 meeting on April 5, 2020 has been cancelled in an effort to keep everyone safe and protected from illness and lessen the threat of illness. It was still felt that canceling the Area meeting was the best service we could provide for our members.

It is my wish that webmasters for these district websites keep meeting cancellations updated as well as any other updates needed within their districts. Please remind them that the information is timely and they are a source of information needed for ALL Members including the new person.

I am here for you and want to be as much of a service that you need. I cannot physically attend all of your meetings or keep up with every meeting in our Area, but I am available to answer questions, concerns you may have. Please reach out. Do not hesitate to call me, text me, or email me. I am serving you, in the same way I always have although it may not be in person.

March 16, 2020

The General Service Office (G.S.O.) has received group inquiries on how to respond to COVID-19 (Coronavirus). The G.S.O. is a repository of shared group experience; functions as a resource for A.A. members and groups in Fellowship shared experience. Guidance on health issues is outside the scope of sharing that G.S.O. offers. We suggest you contact national, state/provincial and local health authorities for appropriate information.

Some groups are addressing this issue. Groups unable to meet at usual meeting places began meeting digitally; in a way to allow the group continued focus on our common welfare and primary purpose.

Groups meeting in person shared changes made: avoiding shaking hands or handholding; ensuring sanitary hospitality tables; suspending food hospitality. Understand that each individual is responsible for their own health decisions.

Groups made contingency plans if the group's unable to meet in person; create contact lists to keep in touch by phone, email, social media, or online. Groups not holding its regular meetings may want to communicate this to local A.A. resources; the district, area and intergroup or central office. Many local A.A. entities added information to their websites on how to change meeting format from "in-person" to online. Groups shared they utilize digital platforms such as Zoom, Google Hangouts, or a conference call. Groups added a "virtual Seventh Tradition basket" to remain self-supporting to keep up the services at the group and the A.A. entities that serve them.

Those with questions regarding A.A. Anonymity Traditions on digital platforms can review Conference-approved pamphlets, Understanding Anonymity (P-47), the G.S.O. Service Material Anonymity Online and Digital Media, and the A.A. Guidelines on the Internet.

The G.S.O. received inquiries on A.A. events it coordinates throughout the year. Visit www.aa.org for up-to-date information on coordinated events. Please be assured that the health and safety of attendees is a priority. G.S.O. is closely monitoring relevant health advisories regarding COVID-19 (Coronavirus). CONCEPT IV EXPLAINED

This Concept provides not only that groups of alcoholics be permitted to participate, but also that staffs that include nonalcoholics should also be permitted the right to vote in proportion to the responsibility they discharge. This insures that every skilled element needed to make informed decision have a right to participate and provides a voice for people with knowledge of how things operate day-to-day.

PRINCIPLE OF CONCEPT IV

The fundamental truth of Concept IV is Equality. As per the Oxford Dictionary, the definition of equality is "the fact of being equal in rights, status, advantages, etc."

What this is all about is the 'Right Of Participation'. All have the right, as can be seen when reading the Long Form, from all parts of the Service Structure. Each 'Right Of Decision' in Concept III is followed through in Concept IV with the participation from all in the 'upside down triangle' of Concept I.

As with the Steps and the Traditions, the Concepts build upon the previous Concepts to form a coherent 'plan of action' for our recovery.

Allowing each a 'Voice' (Concept I) and the 'Conscience' (Concept II) with a 'Right Of Decision' delegated to our trusted servant (Concept III) brings us to the' Right Of Participation' that is Concept IV.

Concept IV talks of being allowed voting representation in reasonable proportion to the responsibility that each must discharge. This too means equality. All have the right to vote through the conscience entrusted to the representative servant, each of which has a responsibility to the fellowship. ~ Doug G.

"The principle of 'Right of Participation' is built into the General Service Conference through the Conference Charter. Voting members include not only delegates, but also the trustees, and the directors and staff members of A.A. World Services (i.e., G.S.O.) and the A.A. Grapevine.


"In the same way, the boards of these two operating entities include as voting members not only trustees, but also nontrustee directors and paid administrators and staff members.

"The chairperson of the General Service Board appoints nontrustee members to the standing committees in order to have the advantage of their expertise, and staff members serve as committee secretaries. "There are no 'superiors,' no 'inferiors,' and no 'advisers."

"Finally, there is a spiritual reason for the 'Right of Participation.' All of us desire to belong. In A.A., no members are 'second class.' The 'Right of Participation' therefore reinforces Tradition Two, that no member is placed in 'ultimate authority' over another. We perform our service tasks better when

we are sure we belong-when our 'participation' assures us we are truly the 'trusted servants' described in Tradition Two."


Someone just asked me, "Who do you think will win the 2020 Presidential Election?"


