"The earliest written reference to the Serenity prayer dates to 1932 in a diary entry by Winnifred Crane Wygal. Wygal was then a pupil of Reinhold Niebuhr, and quoted the prayer in a personal diary, attributing it to the theologist." ¹

"Ruth Hock received a New York Herald Tribune newspaper clipping of the Serenity Prayer in June 1941. Ruth and many A.A. members in New York and elsewhere all immediately feel this prayer's relevancy to A.A.'s principles. The prayer is printed on cards and is being passed out to A.A. members everywhere. The prayer has since become a central part of A.A. heard in meetings around the world."

"The first report of the Serenity Prayers used outside church walls was in 1944 when it appeared in the Book of Prayers and Services for the Armed Forces which was published by the Federal Council of Churches." ³

The principle of Concept VII is Balance.



CONCEPT VII SHORT FORM

"The Charter and Bylaws of the General Service Board are legal instruments, empowering the trustees to manage and conduct world service affairs. The Conference Charter is not a legal document; it relies upon tradition and the A.A. purse for final effectiveness." ³

CONCEPT VII LONG FORM

the Bylaws of the General Service Board are legal instruments: that the Trustees are thereby fully empowered to manage and conduct all of the world service affairs of Alcoholics Anonymous. It is further understood that the Conference Charter itself is not a legal document: that it relies instead upon the force of tradition and the power of the A.A. purse for its final effectiveness." ⁴

CONCEPT VII EXPLAINED

"This concept at first appears to set up a conflict -- the trustees are given full legal authority, but the concept acknowledges that without the backing of the Conference and through it the funds and support of the local groups, the trustees could not, as a practical matter, go completely off on their own." In this way, grave issues will always be resolved and harmonious cooperation will be the general rule." 5

CONCEPT VII CHECKLIST (Service Material from the General Service Office).

- Do we act responsibly regarding the "power of the purse"?
- Do we realize that the practical and spiritual power of the Conference will nearly always be superior to the legal power of the G.S.B.? ⁷

"This means that the practical power of the "The Conference recognizes that the Charter and Conference will nearly always be superior to the legal power of the Trustees. This superior power in the Conference flows from the powerful traditional influence of the Charter itself. It derives from the large majority of group-chosen Delegates in the Conference. And finally, in any great extremity, it would rest upon the undoubted ability of the Delegates to deny the General Service Board the monies with which to operate - viz (namely; in other words), the voluntary contributions of the A.A. groups themselves. Theoretically, the Conference is an advisory body only, but practically speaking it has all of the ultimate rights and powers that it may ever need." 8

The PARADOX and LEGACIES of A.A.

April 30 A GREAT PARADOX

"These legacies of suffering and recovery are easily passed among alcoholics, one to the other...The great paradox of A.A. is that I know I cannot keep the gift of sobriety unless I give it away." 9

Paradoxes are discussed several times in the 12 Steps and 12 Traditions, and in the Big Book examples abound;

"Without unity, A.A. dies. Individual liberty, yet great unity. Key to paradox: each A.A.'s life depends on obedience to spiritual principles. The group must survive or the individual will not. Common welfare comes first." 10

"Step One showed us an amazing paradox: We found that we were totally unable to be rid of the alcohol obsession until we first admitted that we powerless over it." 11

"And then he discovers that by the divine paradox of this kind of giving he has found his own reward, whether his own brother has yet received anything or not " 12

"We never apologize to anyone for depending upon our Creator. We can laugh at those who think spirituality (is) the way of weakness. Paradoxically, it is the way of strength." 13

The Legacies of A.A. left for us to follow through the experience of Bill W. and Bob S. are set forth as thus; Recovery through the 12 Steps. Unity through the 12 Traditions. Service through the 12 Concepts.

"The circle stands for the whole world of A.A., and the triangle stands for A.A.'s Three Legacies of Recovery, Unity, and Service. Within our wonderful new world, we have found freedom from our fatal obsession. That we have chosen this particular symbol is perhaps no accident. The priests and seers of antiquity regarded the circle enclosing the triangle as a means of warding off spirits of evil, and A.A.'s circle and triangle of Recovery, Unity, and Service has certainly meant all of that to us and much more." 14

The PTHA is composed of six members, all receiving no salary or compensation. The Terms of Office are for three years. The executive officers shall be, Chairman, Registered Agent/Secretary, and a Treasurer. The FAUC is an ex-offico member of the Board of Trustees.

There are four Trustee positions to stand for terms at this time.

Each Trustee shall one vote and serve at-large, without representing any fractional jurisdiction, interest, or constituency.

The PTHA Treasurer serves the FAUC with monthly reports, shall have custody of the FAUC funds with full and accurate accounts of receipts and disbursements for the FAUC. The PTHA is responsible for any and all I.R.S. filings and accuracy.

The Board of Trustees oversees as a check and balance the workings of the Treasurer with each Trustee having one vote upon matters of consideration and electives of new Board Trustees.

The PTHA is accepting applications for consideration of joining the PTHA as a Trustee.
