



The inscriptions read:

"This in gratitude for your recovery and your fine example. - Ever Bill" - "NY / 5/2/58"

This book is in excellent condition with minimal wear. The dust jacket has light edge wear and chipping. Other than the inscriptions, there is no writing or markings in the book<sup>-2</sup> (Along with image).

"WE, of Alcoholics Anonymous, are more than 100 men and women who have recovered from a seemingly hopeless state of mind and body. To show other alcoholics *precisely how we recovered* is the main purpose of this book"<sup>3</sup>

On pages 10 and 11 of this Newsletter is a listing of the members of Alcoholics Anonymous when the volume was first printed in April 1939. It explains how the phrase "100 men and women" came about.

#### **STEP FOUR**

The first three Steps of the A.A. program of recovery are referred to as The Foundation of our recovery. This, in part, is due to the writing of "Willingness, honesty and open mindedness are the essentials of recovery." <sup>4</sup> Honesty comes about in the first Step, where our being honest leads us to admit our "...powerlessness over alcohol..." <sup>5</sup> Openmindness comes in the second Step where we accept there is a "...Power greater than ourselves..." <sup>6</sup> So then, Willingness is in the third Step where we "...turn our will and our lives over to the care of God as we understood Him." <sup>7</sup>

So then the Foundation is laid, and "...this concept was the keystone of the new and triumphant arch through which we passed to freedom." <sup>8</sup>

"Therefore, we started upon a personal inventory. *This was Step Four*." <sup>9</sup>

This is where the action of the program begins my sponsor told me. Right or wrong about that does not matter, what matters is through guidance and my asking questions, I was able to complete an honest and thorough inventory of my past.

"The benefits of completing Step Four are strengthened sobriety, spiritual growth and movement towards mending your relationships to your HP, yourself and other human beings. What's the biggest requirement for this action step? Be honest! You and the people around you will benefit from this crucial step. In case you didn't know, keeping secrets is threatening to our recovery, and we have all had secrets that nearly killed us. Our secrets, in and out of sobriety, keep us sick.

"The inventory you will do in Step Four of AA will help you to identify negative thoughts, emotions, and actions that have ruled your life. In the past you probably justified bad behavior and blamed other people, places, or things for the problems you had created. Now you will begin to take responsibility for all your past and current actions. This may mean even acknowledging "painful, embarrassing, or difficult events, thoughts, emotions, or actions. But that's cool, it's all good, because your thoughts, feelings, and beliefs are actually the roots of your addictive behaviors.

"Most of the people you will be relying on to guide you through Step Four probably believe there is no exact right or wrong way to practice this step. I think that what is important, is that we follow the general principle of self-honesty, and that we are willing to be "searching and fearless" in the pursuit of truth (By the way, when we say "fearless," we do not mean you will have no feelings of fear; fearless means you will not let your fears stop you from being thorough in your inventory process. With Step Four, it means you commit to rigorous honesty as you focus on events in your life, including your own weaknesses, and specifically not on anyone else's weaknesses).

"If the thought of making that searching and fearless inventory of yourself feels overwhelming, know you are not alone. My heart goes out to you as I remember my struggles to find the willingness to complete this step. The key is to put pen to paper and just start.

"Even though remembering the past may be painful, it can propel you into a new life of peace, as you learn how to look back without staring. Ask someone who has completed this step how it helped him or her, and how the hope of recovery can help you through the pain of remorse to the joy of forgiveness." <sup>10</sup>

Some of the best advice in the missive above on the fourth step is to use someone in recovery that has completed the steps as a resource to see how it helped. Go to page 13 to see the Promises of the Fourth Step.

#### **TRADITION FOUR**

Short version: "Each group should be autonomous except in matters affecting other groups or A.A. as a whole." <sup>11</sup>

Long version: "With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted. And no group, regional committee, or individual should ever take any action that might greatly affect A.A. as a whole without conferring with the Trustees of the General Service Board. On such issues our common welfare is paramount." <sup>12</sup>

Have you ever heard, Don't take yourself too damn seriously? Or what about this one: Everyone has a right to be wrong?

Both are foundational to and baked into Tradition Four.

In the early days of A.A., many groups were forming. In one town (known as Middleton in the 12 & 12), a certain group's elders began dreaming about building an "alcoholic center" with a club on the ground floor, a sober-up second floor that would provide alcoholics money to pay debts, and a third floor dedicated to education.

Though there were skeptics, money flowed into the project, and the freshly painted center soon opened its doors. In fact, the "gleaming center" was to be a prototype for other such centers.

The main promoter of the deal organized three corporations, and became president of them all. "To insure foolproof, continuous operation, sixty-one rules and regulations were adopted." (12 & 12, p. 228).

But the new center was not destined to glitter long. "Confusion soon replaced serenity." (12 & 12, p. 228). Some trying to get into the center wanted education, but doubted they were alcoholics. Others simply wanted a loan. Still others started at the top floor and worked their way down to the bottom floor. Yet others started in the club, went on a binge, were hospitalized, and then went for education on the third floor. And others tried to get assistance from all three floors. "It was a beehive of activity, all right, but unlike a beehive, it was confusion compounded. An A.A. group, as such, simply couldn't handle this sort of project." (12 & 12, p. 229)

Eventually, the main project promoter wrote the Foundation office (now known as the General Service Office), saying he wished he would have paid more attention to A.A. experience before embarking on the project. He then included the following on a small piece of paper. The cover said: "Middleton Group #1, Rule #62". Once the card was unfolded a single pungent sentence leaped to the eye: 'Don't take yourself too damn seriously.'

So it was under Tradition Four that an A.A. group "had exercised its right to be wrong." Organizers dusted themselves off, learned from their mistakes, and the "chief architect, standing in the ruins of his dream" laughed at himself, and in doing so, demonstrated great humility.

This story is full of lessons for us today. From it we learn that "every A.A. group can manage its affairs exactly as it pleases, except when A.A. as a whole is threatened." Each A.A. group has the freedom to be and do its own thing, according to group conscience, as long as its actions do not "greatly injure A.A. as a whole" or cause it to "affiliate itself with anything or anybody else" (12 & 12, p. 226). Sobriety has to be a group's "sole objective." In all other respects, there is "perfect freedom of will and action" (12 & 12, p. 227).

And then there is the ultimate freedom encapsulated on p. 227 of the Twelve and Twelve: every group has the "right to be wrong."

As an individual A.A., if you disagree with a rule passed by group conscience in one meeting, you are free to go to another meeting in Genesee or any other county. Or you can go to one of the group's business meetings and share your opinion, experience, strength, and hope. You are always free to do service work and give back to the group in another way even when you disagree with a rule voted on by group conscience. Alternatively, you can meditate on Rule 62, how it applies to the situation, pray for the group and its elders, practice patience and tolerance, keep coming back, and be a Big Book walking around.

All the tools are walking around with you in your AA toolbox. It's up to you to open it and use the tools. Just keep coming back. It works if YOU work it.

An oldie:



#### **CONCEPT IV**

"At all responsible levels, we ought to maintain a traditional 'Right of Participation,' allowing a voting representation in reasonable proportion to the responsibility that each must discharge." (Short Form). <sup>11</sup>

"Throughout our Conference structure, we ought to maintain at all responsible levels a traditional 'Right of Participation,' taking care that each classification or group of our world servants shall be allowed a voting representation in reasonable proportion to the responsibility that each must discharge." (Long Form).<sup>12</sup>

AA provides that all groups within AA should be given a right to participate in the affairs of AA. This Concept provides not only that groups of alcoholics be permitted to participate, but also that staffs that include nonalcoholic's should also be permitted the right to vote in proportion to the responsibility they discharge. This insures that every skilled element needed to make informed decision have a right to participate and provides a voice for people with knowledge of how things operate day-to-day.


Yet, it goes much deeper than that. As the groups are on the top of the inverted triangle of A.A.'s structure, in accordance with the Second Tradition, the group puts forth its ideas and own structure through a group conscience, which has but one ultimate authority. The leaders are trusted servants, they do not govern. This Fourth Concept then ensures each individual member of A.A. a voice, and more importantly, a vote in the group conscience.

"Everyone, both inside and outside of AA, has a desire to find their rightful place in the world. Bill saw the program as something that would give recovering alcoholics a chance to find a fellowship in which they felt they truly belonged. Concept IV may seem like it is primarily concerned with enforcing the Second Tradition, but it is about much more than ensuring the lack of an ultimate authority. It is about ensuring that AA members understand how vital they are to the survival of the program. If we are to share equal rights, then it only follows that we should all share equal respect as well." <sup>13</sup>



"The 'Right of Participation' is therefore a corrective of ultimate authority because it mitigates its harshness or misuse. It also encourages us who serve A.A. to accept the necessary disciplines that our several tasks require. We can do this when we are sure that we belong, then the fact of our 'participation' assures us that we are truly the 'trusted servants' described in A.A.'s Tradition Two." <sup>14</sup>







## CONCEPT FOUR CHECKLIST

Because our General Service Conference represents us all, this body is especially charged with the duty of setting the highest possible standard with respect to these attitudes of no punishments and no public controversy. The Conference will have to do more than just represent these principles; it will frequently have to apply them to specific situations. And, at times, the Conference will need to take certain protective actions, especially in the area of Tradition violations. This action, however, never need be punitively or aggressively controversial at the public level.

Therefore it becomes clear that ultimate authority is something which cannot be used indiscriminately. Indeed ultimate authority should practically never be used in full, *except in an emergency*. That *emergency* usually arises when delegated authority has gone wrong, when it must be reorganized because it is ineffective, or because it constantly exceeds its defined scope and purpose. For example, if the groups are dissatisfied with the Conference, they can elect better Delegates or withhold funds. If the Delegates must, they can censure or reorganize the Trustees. The Trustees can do the same with the service corporations. If a corporation does not approve of the operations of its executives or staff, any or all of them can be fired.

Therefore we expect that our Conferences will always try to act in the spirit of mutual respect and love — one member for another. In turn, this sign signifies that mutual trust should prevail; that no action ought to be taken in anger, haste, or recklessness; that care will be observed to respect and protect all minorities; that no action should ever be person ally punitive; that whenever possible, important actions will be taken in substantial unanimity; and that our Conference will ever be prudently on guard against tyrannies, great or small, whether these be found in the majority or in the minority.

There are provisions in the Service Manual for the stated purpose of protective actions. Ultimate Authority can be used *in an emergency*. This emergency action is stated in the F.A.U.C. Aims and Purposes under Election Procedures numbers 11 and 12. And as stated in item 7 of the Aims and Purposes, "The Twelve Traditions and Twelve Concepts of A.A. shall prevail at all times." This then gives the F.A.U.C. the Right of Participation with votes on the conduct unbecoming the Traditions and Concepts of an A.A. member participating in the F.A.U.C.. The circumstances called out in the Service Manual are areas of Traditions violations; because it is ineffective; or to act in the spirit of mutual respect and love. Love is not an emotion, which creates feelings, feelings don't act. It is a willful act, which may be based on feelings.

## Quote of the Week "Welcome to A.A., the place where you grow up in public."

After a few months in the program, I began hearing people share that their emotional development stopped at the age they started drinking. They said they felt as if they had the coping skills, and the emotional responses to situations and people, that they had when they were teenagers—or younger. I was seventeen when I started drinking, and I, too, felt baffled by how to deal with people, places, and things. Many of my reactions were that of a selfish and selfcentered adolescent.

When I started working the Steps, I heard another saying that people also felt as if they had missed that day at school when they handed out the instruction manual to life. I really related to that. The good news, my sponsor assured me, was that the Twelve Steps would provide the best instruction ever, and that I only had to be rigorously honest and willing throughout the process. As I uncovered, discovered, and discarded my old self, and built a relationship with my Higher Power, I began to grow up. But it wasn't always pretty.

I made a lot of mistakes as I evolved and changed over the years. It was often embarrassing, and sometimes even a little humiliating, to admit my mistakes and some of my ongoing selfish thoughts and behaviors during meetings with other people. But the acceptance I found, the identification and support I received, made it safe to discover myself and grow into the man I am today. And the laughter! When I learned to laugh at myself, I learned to forgive myself. And that's what made growing up in public possible, and even enjoyable at times.



□Conviction and Compromise

One qualification for a useful life is give-and-take, the ability to compromise cheerfully. Compromise comes hard to us "all or nothing" drunks. Nevertheless, we must never lose sight of the

fact that progress is nearly always characterized by a series of improving compromises.

Of course, we cannot always compromise. There are circumstances in As Bill See's It which it is necessary to stick flat-footed to one's convictions until the issue is resolved.

Deciding when to compromise and when not to compromise always calls for the most careful discrimination.

TWELVE CONCEPTS, PP. 42-43

An analogy of compromises and convictions here; compromises are our values while convictions are our absolutes.

If your car needs gas, the only thing one can put in it to make it run is, you guessed it, gas! That is an absolute. You cannot put any other liquid in it, say; vinegar, milk, diesel fuel, shampoo, laundry detergent, urine, orange juice, alcohol, or you name it. If you do all you've done is the wrong thing, because it was not the absolute, the only thing that will make the engine work.

However, if you drive down the street past different gas stations, the price varies from station to station. That is the compromise; the value of the absolute we are willing to pay, or maybe required to obtain at any price.

Convictions guide our thoughts, behaviors, and they may affect other people also.

Comprise gives us tolerance, patience, kindliness and love by not forcing our conviction upon others.





# **EXPLANATION OF TERMS**

Resentment is the consequence of being angry of bitter with someone for an extended period of time over some real or imagined insult. It is a hostile or indignant attitude in response to alleged affront or personal injury

Fear is being afraid of losing something we have or not getting something we want. It manifests itself in many ways including phobia, terror, panic, anxiety and worry.

Selfishness is concern only for ourselves, our own welfare or plesure, without regard for, or at the expense of others. Dishonesty involves theft or deception. It includes taking things that don't belong to us, cheating people out of what is rightfully theirs, and lying to or witholding the truth from others.

Feelings of inferiority include self-pity, which is excessive concern about our own troubles, and low self-esteem - the False Pride is either feeling better of less than someone else. Feelings of superiority include prejudice about race, education or religious beliefs, and sarcasm -putting someone else down to make us feel better about ourselves lack of self-worth or self-respect.

Jealousy has to do with people - being suspicious of another's motives or doubting the faithfulness of a friend. Envy has to with things - wanting someone else's possesions.

Laziness means lacking the will of the desire to work. Procrastination, which is postponing or delaying an assigned ob or task, is a form of laziness. Copyright: Faith With Works - Publishing Company, Wally P., 1997, 1998, (Rev. 06/06)






