People recover, grow, leave behind obstinacies; they become Happy, Joyous, and Free!

"So in a very complete and literal way, all A.A.'s have become entirely ready' to have God remove the mania for alcohol from their lives. And God has proceeded to do exactly that." 1

Step 6.

"What Does Step 6 Mean in AA?

"As defined by the official 12-step AA program, step 6 requires that participants "were entirely ready to have God remove all these defects of character."

"It relies a bit on information curated in step 5. In that step, you are asked to admit to God, yourself, and another person 'the exact nature of our wrongs.'

"So in order to complete step 6, you have to take all of the wrongs you listed in step 5 and consider them in your mind. Then you have to mentally commit to changing the behavior that caused these mistakes.

"Sure, it will be easy to say you'll never make a mistake again. However, actually vowing to change the behavior that led to the mistakes, such as drinking too much, can be much harder to achieve.

"Luckily, by asking God, you'll have extra strength and courage along the way.

"Defining Defects of Character in Step 6

"Before you can ask God to heal you, however, you need to first understand what exactly constitutes a 'defect of character.'

"Basically, your character defects refer to your old style of living. It's not about nitpicking specific mistakes or encounters; instead, it's about changing the personality traits and habits that created and led to these mistakes.

"Overall, by defining these defects, you are preparing to officially shed your old, addict life and "move on to something brighter and better.

"Step 6 of AA Therapeutic Healing

"With step 6, comes a huge feeling of healing. By becoming aware of your old patterns, you can finally take responsibility for them. By trusting in and relying on God, you can shift these problems over to Him.

"He will bear the burden for you, so that you can officially let go and move on.

"At the end of step 6, you'll finally be able to drop your outdated defenses and feel a delayed gratification that might have been years in the making.

"Alcoholics Anonymous Spiritual Awareness

"Even if you don't believe in a particular god, AA still asks that you confide in a non-specific Higher Power to guide you on the path of sobriety.

"By handing over your old habits to this Power, you will instantly feel a huge burden being lifted off of your shoulders.

"You'll also feel much closer to this entity and have a heightened sense of connection with the mystical world around you.

"By opening yourself up to new spiritual awareness, you can begin to forgive yourself and grieve for the moments you've lost in the past. You can also begin to heal your old relationship patterns and develop a new and improved healthy sense of self." ²

STEP SIX

"Were entirely ready to have God remove all these defects of character." ³

"This is the Step that separates the men from the boys. So declares a well-loved clergyman who happens to be one of A.A.'s greatest friends. He goes to explain that any person capable of enough willingness and honesty to try repeatedly Step Six on all his faults – without any reservations whatever – has indeed come a long way spiritually, and is therefore entitled to be called a man who is sincerely trying to grow in the image and likeness of his own Creator." ⁴

"It is plain for everybody to see that each sober A.A. member has been granted a release from this very obstinate and potentially fatal obsession. So in a very complete and literal way, all A.A.'s have 'become entirely ready' to have God remove the mania for alcohol from their lives. And God proceeded to do exactly that.

"Having been granted a perfect release from alcoholism, why then shouldn't we be able to achieve by the same means a perfect release from every other difficulty or defect? This is a riddle of our existence, the full answer to which may be only in the mind of God. Nevertheless, at least a part of the answer is apparent to us.

"As they are humbled by the terrific beating administered by alcohol, the grace of God can enter them and expel their obsession." ⁵

THE RIGHT KIND OF HELP


A drunk fell in a deep hole. A businessman came by as he called for help, threw him some money and told him get a ladder. But the drunk in a hole felt hopeless.



TRADTION SIX

"An A.A. group ought never endorse, finance or lend the A.A. name to any related facility or outside enterprise, lest problems of money, property, and prestige divert us from our primary purpose." ⁶

"Problems of money, property, and authority may easily divert us from our primary spiritual aim. We think, therefore, that any considerable property of genuine use to A.A. should be separately incorporated and managed, thus dividing the material from the spiritual, An A.A. group, as such, should never go into business. Secondary aids to A.A., such as clubs or hospitals which require much property or administration, ought to be incorporated and so set apart that, if necessary, then can be freely discarded by the groups. Hence such facilities ought not to use the A.A. name, their management should be the sole responsibility of those people who financially support them. For clubs, A.A. managers are usually preferred. But hospitals, as well as other places of recuperation, ought to be well outside A.A. – and medically supervised. While an A.A. group may cooperate with anyone, such cooperation ought never go so far as affiliation or endorsement, actual or implied. An A.A. group can bind itself to no one."

CONCEPT VI

"The Conference recognizes that the chief initiative and active responsibility in most world service matters should be executed by the trustee members of the Conference acting as the General Service Board." ⁸ (Short Form).

"On behalf of A.A. as a whole, our General Service Conference has the principal responsibility for the maintenance of our world services, and it traditionally has the final decision respecting large matters of general policy and finance. But the Conference also recognizes that the chief initiative and the active responsibility in most of these matters should be exercised primarily by the Trustee members of the Conference when they act among themselves as the General Service Board of Alcoholics Anonymous." (Long Form).

"Just as the A.A. groups find themselves unable to act decisively respecting world service affairs unless they delegate a great amount of active authority and responsibility to their Conference, so must the Conference in turn delegate a liberal administrative authority to the General Service Board in order that its Trustees may act freely and effectively in the absence of the Conference itself." ¹⁰

"Just as the groups must as a practical matter delegate much of their authority to the Conference, so the Conference must delegate much of its authority to the Trustees; otherwise the Trustees would be unable to act in the absence of the Conference. In essence, AA operates like a corporation with the groups being stockholders who elect Delegates who act on their behalf at the 'Annual Meeting' or Conference. The General Service Board Trustees are essentially the directors of the "holding company" that owns and controls the subsidiaries that actually carry on much of the work of AA." ¹¹

"The trustees of the General Service Board of Alcoholics Anonymous are concerned with everything happening inside and outside A.A. that may affect the health and growth of the Fellowship.


"The A.A. charter envisions the trustees as 'custodial' in their duties, meaning they are focused upon the welfare of the Fellowship and its members alone. (Continued on top of next column).


"A custodial relationship between the trustees and the Fellowship means their ourpoose is to safeguard the vital services provided for the Fellowship, not to govern. This relationship asks the trustees to be informed and thoughtful in their actions and to keep the Fellowship's best interests at heart. It expects the trustees to be vigilant and proactive on A.A.;s behalf, so we – the membership of A.A. – can get to work helping alcoholics get and stay sober.

"The trustees are very much part of the upside-down triangle." ¹²

"The board of trustees consists of 21 people who bring varying talents and backgrounds to the service responsibilities. There is always a careful balance on the board between trustees who are elected primarily for business or other professional backgrounds. In seeking applications for all trustee vacancies, the board is committed to creating a large file of qualified applicants that reflects the inclusiveness and diversity of A.A. itself.

"The board is divided into two 'classes.' This is outlined in the table below." ¹³





- 4. Should the secretary of our group serve on the mayor's advisory committee on alcoholism?
- Some alcoholics will stay around AA only if we have a TV and card room. If this is what is required to carry the message to them, should we have these facilities


Some of these questions are so outdated! Take number 4 for an example;

The City of Flint (In District 12 of Area 32 of Alcoholics Anonymous) does not have a "mayor's advisory committee on alcoholism". It does however have an "Office of Public Health". So following the guideline questions, this Tradition Six questionnaire could open up a very valuable discussion that becomes a part of the group's primary purpose as stated in Tradition Five;

". Each group has but one primary purpose...to carry its message to the alcoholic who still suffers."

CONCEPT SIX CHECKLIST

- Are we familiar with how our General Service Board (G.S.B.) Class A and Class B trustees serve A.A.? Are we familiar with how our other trusted servants serve A.A.?
- Are we clear about the terms, "chief initiative" and "active responsibility"? Can we see a direct link to our home group?

The term "chief initiative" is as stated in the A.A. Preamble, "Our primary purpose is to stay sober and help other alcoholics achieve sobriety."

The term "active responsibility" will be discussed in Concept XII, Warranty II as the "prudent financial principle".

"That sufficient operating funds and reserve be its prudent financial principle...

"In this connection we should pause to review our attitudes concerning money and its relation to service effort."

Hazard and fellow Oxford Grouper Ceebra Graves attended Ebby's sentencing hearing in court at Bennington, Vermont. (Graves was the son of the Court Magistrate). Hazard and Graves were able to arrange for Ebby's release into their care. This led to Ebby's own sobriety. Encouraged in the example of personal evangelism, Ebby later sought out an acquaintance of his own.

Ebby shared with Bill Wilson the message of recovery through the application of spiritual principles, famously encouraging Bill to choose his own conception of God. This visit with Ebby set in motion a series of circumstances that led to Bill's own recovery from alcoholism in late 1934.

Bill Wilson went on, with Dr. Robert H. ("Dr. Bob") Smith of Akron, Ohio, to carry the message of spiritual recovery to other alcoholics. The group of recovering alcoholics founded by Wilson and Smith would later become known as Alcoholics Anonymous in 1939.

Both men immediately set to work with alcoholics at Akron's City Hospital. One patient, Bill Dotson, quickly achieved complete sobriety. These three men made up the nucleus of the first A.A. group.

The gratitude in action was helping other alcoholics.

When I came into the rooms, I was buried in shame. Without alcohol to escape into, I was overwhelmed with remorse over many of my actions. As I moved toward working the Fourth Step, I was desperately afraid of what I would find in the abyss of self. I was sure that once I uncovered how bad I really was, no one—including myself—would accept me. I was definitely at a jumping-off place.

As I began putting my inventories together, I discovered something else, though. Yes, I had acted poorly and had made many selfish decisions, but I learned that much of my behavior had been driven by the disease of alcoholism. What I found was that my actions weren't necessarily who I was; they were just my actions. And if I was willing to own those actions, make amends, and stay sober, then I could recover through working the Twelve Steps.

As I continued to uncover, discover, and discard my character defects, I found something even more important. I learned that all my experiences, especially the "bad" ones I felt shame over, would turn out to be the most useful in reaching out to and helping others. I learned that my pain was often the key that allowed others to come to terms with and overcome their own pain. All the experiences I had tried to run from had value, and in God's hands they uniquely qualified me to be of service to His other children. Today, I no longer wish to shut the door on my past, nor on my pain.

So it is no surprise that growing into a new lifestyle; sober, with sobriety, brought about by practicing the principles of the Twelve Steps is going to hurt. Many challenges are ahead in our recovery where it's best to use prayer and meditation, discussion with an A.A. confidant, and remembering that "Faith, to be sure, is necessary, but faith alone can avail nothing." ¹⁵ And also that "Faith without works is dead." ¹⁶ "We must take the lead. ¹⁷ "We must not shrink at anything." ¹⁸ "You won't have to work at it very hard, either." ¹⁹




