"THE seventeenth Christmas for Alcoholics Anonymous is here. Considering all that has happened since AA's first Christmas in 1935, no words can portray the meaning of Christmas 1952. The only thing of which we're really sure is that we have given of ourselves, and have received gifts that no imagination can fully describe. Guided, we are sure, by an all generous and wise Providence, AA's message of hope has been carried into nearly every corner of the earth. The Christmas drama of giving and receiving has been re-enacted everywhere and still goes on."

The eighty-eighth Christmas for Alcoholics Anonymous is here!!!

It's the end of the world as we know it. (And I feel fine). 1

"At the hospital I was separated from alcohol for the last time. Treatment seemed wise, for I showed signs of delirious tremens.

"There I humbly offered myself to God, as I then understood Him, to do with me as He would. I placed myself unreservedly under His care and direction. I admitted for the first time that of myself I was nothing; that without Him I was lost. I ruthlessly faced my sins and became willing to have my new-found Friend take them away, root and branch. I have not had a drink since." ²

Bill W. took his last drink at 39 years of age on December 11, 1934. Imagine exactly two weeks later was Christmas. What a wonderful gift for himself and family and friends.

Let's look at the quoted paragraph above. Which future A.A. Steps did Bill W. go through in that interim of a hospital stay?

Step Three: "There I humbly offered myself to God, as I then understood Him, to do with me as He would. I placed myself unreservedly under His care and direction."

Step Four: "I admitted for the first time that of myself I was nothing; that without Him I was lost." Steps Four and Six: "I ruthlessly faced my sins (4) and became willing to have my new-found Friend take them away, root and branch." (6).

Step 1: I have not had a drink since." Why did Bill proclaim "root and branch". A simple explanation is that if the root isn't taken out, it will return with more branches. Bill saw he needed to eliminate the offending violations of His (God - as he then understood Him), will in Bill's life.

Bill W. further explains, "I was to test my thinking by the new God-conscious within. Common sense would thus become uncommon sense. I was to sit quietly when in doubt, asking only for direction and strength to meet my problems as He would have me." ³

A visit from a schoolmate brought forth the future Steps of A.A. being formulated by Bill's thoughts of what he had to do. "We made a list of people I had hurt or toward I felt resentment. (4) I expressed my entire willingness to approach these individuals (8), admitting my wrong (9)." ⁴

It is true that Bill W. had no idea of the A.A. program of recovery that was to come to fruition through these early efforts to recover. The Foundation of his thoughts on helping others was taking shape.

A blessed Christmas indeed.

STEP TWELVE

"Having had a spiritual awakening as a result of these steps, we tried to carry this message to alcoholics, and to practice these principles in all our affairs." 6

The twelve steps are called the first twelve principles of A.A., followed by the Traditions as another twelve principles, and then the Concepts as the last twelve principles. The three tenets of A.A., Honesty, Openmindness, and Willingness, (HOW), allow the individual, the group, and, the General Service Office, (GSO), to grow and attain the three Legacies of A.A., Unity, Service, and Recovery.

HOW is repeated in order through the twelve steps, but is not necessarily the spiritual principle of the step. (Editor's perspective in *italics*).

- We admitted we were powerless over alcohol that our lives had become unmanageable. Honesty – Self admission of powerlessness and unmanageability.
- 2. Came to believe that a Power greater than ourselves could restore us to sanity. *Openmindness – Believing the Power greater* than our self could help us turn away from the 1st drink and be returned to sanity of proven past insanity of thoughts and actions.
- Made a decision to turn our will and our lives over to the care of God as we understood Him. Willingness – The action of relying on God's will instead of our own.
- Made a searching and fearless moral inventory of ourselves. *Honesty – To be able to look at our self with no*
- 5. Admitted to God, to ourselves, and to another human being, the exact nature of our wrongs. *Openmindedness - to know it is not how many* times we wronged, but that we wronged at all.

- 6. Were entirely ready to have God remove all these defects of character. *Willingness – the essence of being entirely* ready.
- 7. Humbly asked Him to remove our shortcomings. <u>Honesty</u> – accepting help from a Higher Power.
- Made a list of all persons we had harmed, and became willing to make amends to them. *Openmindedness* – to determine in the past any and all that are amendable due to ourselves.
- Made direct amends to such people where ever possible, except when to do so would injure them or others.
 - *Willingness* to be able to go to another with amends due from our actions and/or deeds.
- 10. Continue to take personal inventory and when we were wrong promptly admitted it. Honesty – "...cast up a balance sheet, crediting ourselves with things well done, and chalking up debits where due." 6
- 11. Sought through prayer and meditation to improve our conscious contact with God as we understood Him, praying only for knowledge of His will for us and the power to carry that out. *Openmindedness – knowing that change for us is* His will, attainable by prayer and meditation.
- 12. Having had a spiritual awakening as a result of these steps, we tried to carry this message to alcoholics, and to practice these principles in all our affairs.
 - *Willingness our perspective and personality* has changed to allow us to help others in knowing, practicing, and living recovery.

TRADITION TWELVE

"Anonymity is the spiritual foundation of all of our Traditions, ever reminding us to place principles before personalities." (Short Form), 9

"And finally, we of Alcoholics Anonymous believe that the principle of anonymity has an immense spiritual significance. It reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility. This to the end that our great blessings may never spoil us; that we shall forever live in thankful contemplation of Him who presides over us all." (Long Form). ¹⁰

Tradition Twelve brings the Unity of the First Tradition, the Ultimate Authority of the Second. The Third comes out as humility to have the desire to quit drinking, the Fourth as sticking to our own group contingencies and not affecting A.A. as a whole. The Fifth Tradition has us only following our primary purpose, spiritual in nature when we help other alcoholics.

The Sixth Tradition is portrayed as a principle of the first reiterated as our common welfare. The Seventh is where spirituality and money mix, keeping personalities out of the principle. The Eighth Tradition reminds us that through our paid workers we have great blessings.

The Ninth Tradition is one of delegation that may never spoil us. Tradition Ten brings thankful contemplation on issues to avoid public controversy.

Tradition Eleven is of utmost importance: attraction rather than promotion our A.A. program of recovery through living, not boasting, with Him who presides over us all.

The Twelve Tradition brings all the Traditions together in harmonious action by suggesting principles, not personalities, bringing Anonymity as a spiritual foundation of our society.

CONCEPT TWELVE

"The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualification, induction procedures, and the rights and duties will always be matters of serious concern." ²⁰

"...no organization structure can fully guarantee our Headquarters against the depredations of clashing personalities, that only the sustained willingness to practice spiritual principles in all our affair can accomplish this, and we should never need to have any fear for our future harmony." ¹⁹

"It is the duty of the good executive officer therefore to learn discrimination of when he, (or she), should act on his, (or her), own and limited or wide consultation is proper, and when he, (or she), should ask for specific definitions and directions. This discrimination is really up to him, (or her). His, (or her), privilege of making these choices is structurally guaranteed by the 'Right of Decision'. He, (or she), can always be censured after his, (or her), acts, but seldom before."

Concept XII: The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.

- How do we guard against becoming a "seat of perilous wealth or power"?
- How do we practice prudent use of our Seventh Tradition contributions and literature revenue?
- Do we insure the spiritual liberties of all A.A. members by not placing any member in the position of absolute authority over others?
- Do we try to reach important decisions by thorough discussion, vote and, where possible, substantial unanimity?
- As guardians of A.A.'s traditions, are we ever justified in being personally punitive?
- Are we careful to avoid public controversy?
- Do we always try to treat each other with mutual respect and love?

As explained below, Concept XII is broken into Warranties that the A.A. member, Group, District, Area and G.S.O., A.A.W.S., and The Grapevine are suggested to follow.

Taken as a whole, our Conference Charter is the substance of an informal agreement which was made between the A.A. groups and their Trustees in 1955. It is the agreed basis upon which the General Service Conference operates. In part, the Charter is an elastic document; its first eleven Articles can be readily amended by the Conference itself at any time.

But Article 12 of the Charter stands in a class by itself. An amendment or a cancellation of any of its vital Warranties would require the written consent of three-quarters of all the directory-listed A.A. groups who would actually vote on any such proposals, and the considerable time of six months is allowed for careful deliberation. Although changes in the Warranties of Article 12 thus have been made difficult, they have not been made impossible.

It is clear that all of these Warranties have a high and permanent importance to A.A.'s general welfare. This is why we believe we should permit change in them only upon positive evidence of their defectiveness and then only by common consent of the A.A. groups themselves. We have ranked them therefore with A.A.'s Twelve Traditions, feeling that they are quite as important to A.A.'s world services as the Traditions are to A.A. as a whole.

The Warranties of Article 12 are a series of solemn undertakings which guarantee that the Conference itself will conform to A.A.'s Twelve Traditions; that the Conference can never become the seat of great wealth or government; that its fiscal policy shall ever be prudent; that it will never create any absolute authority; that the principle of substantial unanimity will be observed; that it will never take any punitive action; that it never will incite public controversy; that it can serve A.A. only; and that it shall always remain democratic in spirit. These Warranties indicate the qualities of prudence and spirituality which our General Service Conference should always possess. Barring any unforeseen defects, these are the permanent bonds that hold the Conference fast to the movement it serves.

The Six Warranties of Concept XII.

- 1. Shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power;
- 2. That sufficient operating funds and reserve be its prudent financial principle;
- 3. That it place none of its members in a position of unqualified authority over others;
- 4. That it reach all important decisions by discussion, vote, and whenever possible, by substantial unanimity;
- 5. That its actions never be personally punitive nor an incitement to public controversy;
- 6. That it never perform acts of government; that, like the Society it serves, it will always remain democratic in thought and action. ²⁴



"You may be the only Big Book anyone ever reads."

As I was leaving a meeting at a church near my home the other night, I saw one of our members bring his cigarette onto the church parking lot (smoking is not allowed on church property) and then throw it on the ground as he got into his car and drove away. This made me angry as I thought about how this would reflect on the rest of us, and I wondered how he could be so self-centered and insensitive.

About a week later, I found myself at my bank dealing with an online banking error. I was resentful I had to take the time out of my day, indignant they hadn't been able to fix it over the phone, and I was generally a pain in the ass to the guy who was trying to help me. After he resolved the issue and I calmed down, I thought about the kind of example I was setting and quickly made amends to him for my behavior.

On the way home, I thought about Step Twelve and the importance of practicing these principles in all our affairs. I realized how easy it is for me to still be self-centered and insensitive, and how the Tenth Step helps me guard against these character defects. I also realized that I have a responsibility to the program because I am an example of us all. Today, I work all the Steps to the best of my ability because I know that I may be the only Big Book anyone ever reads.

One of my Sponsors told me over and over, "You must read this Big Book, Understand this Big Book, and, Live this Big Book for you may be the only Big Book someone ever reads, but needs the Big Book." RIP Sarge.

TERM OF OFFICE

DCMs serve a term of two years. Alternate DCMs also serve two years. In many areas DCM terms coincide with those of the "panel" covering the area delegate's term of service. (See Glossary for a definition of "Panel.")

DUTIES & RESPONSIBILITIES

Every district is different, but the following are relatively common service activities undertaken by DCMs:

- 1. Regularly hold district meetings. DCMs are asked to give reports to the GSRs on news, issues, proposals and future events from the area and G.S.O. It is also important for DCMs to keep the GSRs informed about Conference activities, perhaps even assisting the delegate in reporting the proceedings of the General Service Conference, either by organizing report-backs or delivering the reports to their districts in lieu of the delegate. GSRs are typically asked to report on what's happening in their groups, and DCMs can make sure that GSRs have what they need in order to assure good communication across the service structure. (See the section titled "Making Reports" in Chapter 1 for a list of publications that can be helpful to DCMs in making reports to the district.)
- 2. Regularly attend area assemblies. The number of assemblies during the year varies by area. All DCMs (and GSRs) from around the area are asked to attend. DCMs (and GSRs) are voting members of these assemblies. (See Chapter 3 for more information on the area and assemblies.)
- **3.** Reach out to groups in the district that do not have GSRs. Some groups may have little or no history of electing GSRs. Some may have had active GSRs in the past, but no longer. The DCM is asked to open a line of communication with these groups. The purpose is not to badger them into electing GSRs, but to begin to connect them to A.A. as a whole.
- 4. Organize workshops and/or sharing sessions on service activities.
- Bring Traditions problems to the attention of the delegate.
- **6.** Help GSRs become acquainted with *The A.A. Service Manual/Twelve Concepts for World Service*. DCMs can also be helpful by introducing the GSRs to *Box 4-5-9* and service material from G.S.O., which includes workbooks and guidelines on an array of topics.
- 7. Alert the district's GSRs to new literature, service materials and technology applications from G.S.O. and Grapevine. This includes new books published by A.A. World Services and the Grapevine. The literature catalogs of the two corporations are an excellent resource. DCMs often hear about new literature before it appears in the catalog, and it can be helpful to alert GSRs on what's coming. The groups may have questions and comments on these. The DCM can help the GSRs address these while also passing them along to the area and the delegate.
- **8.** Assist the delegate in obtaining group contact information for A.A. Regional Directories. These directories are used for A.A. purposes only. They include information on individual groups by city within each province or territory, with contact information on group contacts.
- **9.** In many areas, DCMs attend area committee meetings in addition to area assemblies. The purpose and scheduling of these meetings varies by area. (For more information, see Chapter 4 of this manual on the area committee.)

Dear Trusted Servants:

A.A.'s Co-Founder, Bill W., in his 1953 address to the General Service Conference, stated that he did not consider himself the author of Alcoholics Anonymous, the Big Book (Our Great Responsibility, p. 92). He also alluded to the fact that in the various A.A. literature published prior to his passing, he borrowed heavily from other sources, and that other A.A. members made significant contributions.

On the other hand, addressing the historical context of some of the writings of our Founders, many members in our Fellowship have expressed strong sentiment against any changes in the first 164 pages of Alcoholics Anonymous, the Big Book, as well as the Preface, the Forewords, The Doctor's Opinion, Doctor Bob's Nightmare, and the Appendices. In fact, as early as 1995 and most recently in 2022, Advisory Actions designed to protect the above-referenced contents have been passed by the General Service Conference.

In response to a Committee Consideration from the 73rd General Service Conference suggesting that trustees' Literature Committee seek input from the Fellowship (including but not limited to Area delegate feedback) regarding any possible future changes to literature written by A.A.'s Founders, the trustees' Literature committee agreed it would be beneficial to gather shared experience from the Fellowship regarding this topic.

We would like to hear from you – the top of the triangle! While we hope that the suggested questions will help to spark thoughtful sharing and discussion, please feel free to add questions that we may not have thought of that you feel may best inform the discussion. Most of all, we are grateful for and thank you for your participation.

Aims & Purposes (read)

FLINT AREA UNITY COUNCIL AIMS AND PURPOSES

- 1. To promote Unity among Flint Area A.A., and harmony with Al-anon and Al-Ateen groups.
- 2. To exchange group ideas.
- 3. The G.S.R.'s and Alternates shall act as trusted servants of their groups.
- 4. Each group shall be represented by a G.S.R. or Alternate. One vote per group shall be allowed in determining matters of policy and action affecting the groups. (Committee Chairs are allowed one vote.)
- 5. To continue advancement of Twelve Step work and sponsorship.
- 6. To help financially any member group of this Council who needs help. A two-thirds majority vote will pass on any such loans which shall not be in excess of sixty days.
- 7. The Twelve Traditions and Twelve Concepts of A.A. shall prevail at all times.
- 8. No monies will be spent or sent out of the Council area without a two-thirds majority vote of the groups that have paid into the council in the last three months. If they are not present they will be contacted for a vote on the issue within one week.
- 9. The Council will create Service Committees and be financially responsible for them.
- 9a. Each Service Committee shall receive \$50.00 seed money reimbursable upon submission of receipt for less than \$50.00 Amounts over that must be pre-approved by the F.A.U.C.
- 9b. D.C.M.'s are to receive \$50.00 seed money under the same terms as Service Committees.
- 9c. D.C.M.'s can submit mileage to be paid for attending the CMIA32 meetings.

 This was approved by the F.A.U.C. during the June 18th, 2022, F.A.U.C. meeting. Mileage to be paid at I.R.S. reimbursement rate. (2023 standard mileage rate is \$0.65.5 per mile Revised 6/17/23).

ELECTION PROCEDURES

- 1. Nominations will be held at the November meeting for the following offices and committee chairs: Chairperson, Secretary, Treasurer, Answering Service, Cooperation with the Professional Community, Corrections, Public Information, Grapevine, Literature/Meeting Books, Special Needs, Treatment Facilities, Website, and Young People.
- 2. The Election will be held at the December meeting.
- 3. Election by written ballot and plurality (majority) rule.
- 4. One vote per group, D.C.M.'s are allowed one vote. Past and Present Delegates that are presently active in the Council Area have one vote.
- 5. On any tie vote, a drawing will take place to determine the winner.
- 6. No requirements will be placed upon the G.S.R. as to length of sobriety or donation to the Council.
- 7. The groups voting must be registered in the New York Office.

- 9. Office holders must be members of Unity Council.
- 10. Alternates will be the choice of the office holder.
- 11. After a second consecutive absence from the FAUC meeting, with neither an alternate nor a report submitted by a committee chair, the FAUC chair shall try to notify that committee chair of action pending upon their third consecutive absence.
- 12. Office holders shall be removed from any position if failing to attend three consecutive FAUC meetings and have neither an alternate nor a report submitted. Upon removal the FAUC chair will ask the removed committee chair that the committee seed money and any FAUC materials provided to do that service work be returned. 
