Second, to get sober and to stay sober, you don't have to swallow all of Step Two right now. Looking back, I find that I took it piecemeal myself. (ED note: piecemeal is defined as; characterized by unsystematic partial measures taken over a period of time).



Third, all you really need is a truly open mind."²

"If I gave you time to change my mind I'd find a way to leave the past behind."³

"Even my excuses sound hollow to myself"⁴

STEP TWO

"Came to believe that a Power greater than ourselves could restore us to sanity."⁵

Step Two is the Step that had me considering what I knew about a Higher Power. I acknowledged the three parts of this step;

1. "Came to believe..."

This means if I came to believe, I did not have this belief before.

2. "...a Power greater than ourselves." (myself),

"Had this power originated in him? Obviously it had not. There had been no more power in him than there was in me at that minute: and that was none at all"⁶

"Why don't you choose your own conception of God?"

"It was only a matter of being willing to believe in a power greater than myself. Nothing more was required of me to make my beginning."⁸

3. "...could restore us to sanity."

"Then came the insidious insanity of that first drink..." 9

"Again it was the old, insidious insanity -- that first drink."¹⁰

The suggestion, the example so aptly given, is to avoid the insanity of that first drink, And to do so, I needed help from a Power greater than myself. A new belief, a way out, and that is called restore to sanity.

TRADITION TWO

"For our group purpose there is but one ultimate authority...a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants...they do not govern." ¹² (Short Form).

"For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience." ¹³ (Long Form).

This is no conundrum; what the Big Book refers to as a dilemma or a paradox.

Define dilemma: "a situation involving such a choice." ¹⁴ (Dilemma synonym is Predicament).

"The moment they read Step Two, most A.A. newcomers are confronted with a dilemma, sometimes a serious one." ¹⁵

"Relentlessly deepening our dilemma, our sponsors pointed out our increasing sensitivity to alcohol -- an allergy, they called it." ¹⁶

"Lack of power, that was our dilemma." ¹⁷

"Obviously, the dilemma of the wanderer from faith is that of profound confusion." ¹⁸

Define paradox: a statement that is seemingly contradictory or opposed to common sense and yet is perhaps true. ¹⁹ (Paradox synonym is incongruity).

"Those who look closely soon have the key to this strange paradox." ²⁰

"And then he discovers that by the divine paradox of this kind of giving he has found his own reward, whether his brother has yet received anything or not."²¹

"It is the great paradox of A.A. that we know we can seldom keep the precious gift of sobriety unless we give it away."²²

It is this member's firm ascertaition that the dilemma and the paradox have become nonexistent through following the Twelve Steps and guidance from the Fellowship and my sponsor. Not only in details of the suggestions, but in observing and living the encouraged practices. No phenomena of craving, no lack of choice from abstinence; blessed with a personal relationship to a greater Power, wisdom of the Fellowship, willingness to be restored to sanity, showing others how I could do it through these simple suggestions. This complicated person; a previously warped twisted mind and body of disease; avoids insidious insanity.

By recognizing I needed to be restored to sanity, and a greater Power that could indeed help, now this new belief was a beginning for me, and that as the guidance set in, I became a believer in my outcome.

"If he did not work, he would surely drink again, and if he drank, he would surely die." ²³

As I have learned in Fellowship meetings, this "surely die" refers not only to the protracted, certain debilitation of my physical being, but also to the spiritualality I have of a Power greater than myself, and the loss of a new found secure, safe, relationship.

I now can be "harmonious in brotherly action"²⁴ and "follow the dictates of a Higher Power."²⁵

As Bill W. says, "The principle of amply delegated authority and responsibility to 'trusted servants' must be implicit from the top to the bottom of our active structure of service. This is the clear implication of A.A.'s Tradition Two."²⁹

Court Ruling from the UK

A seven year old boy was at the centre of a courtroom drama yesterday when he challenged a court ruling over who should have custody of him.

The boy has a history of being beaten by his parents and the judge initially awarded custody to his aunt, in keeping with the child custody law and regulations requiring that family unity be maintained to the degree possible.

The boy surprised the court when he proclaimed that his aunt beat him more than his parents and he adamantly refused to live with her. When the judge suggested that he live with his grandparents, the boy cried out that they also beat him.

After considering the remainder of the immediate family and learning that domestic violence was apparently a way of life among them, the judge took the unprecedented step of allowing the boy to propose who'd have custody of him.

After two recesses to check legal references and confer with child welfare officials, the judge granted temporary custody to the England Football (Soccer) team, the boy firmly believes they are not capable of beating anyone. (It might have been the Detroit Lions in 2008 with a 0-16 record...).



When he was 40, the renown Bohemian novelist and short story writer FRANZ KAFKA, (1883-1924), who never married and had mo children, was strolling through Steglitz Park in Berlin. He chanced upon a young girl crying her eyes out because she had

lost her favorite doll. She and Kafka looked for the doll without success. Kafka told her to meet him there the next day and they would look again.

The next day, when they still had not found the doll, Kafka gave the girl a letter "written" by the doll that said, "Please do not cry. I have gone on a trip to see the world. I'm going to write to you about my adventures."

Thus began a story that continued to the end of Kafka's life.

When they would meet, Kafka read aloud his carefully composed letters of adventures and conversations about the beloved doll, which the girl found enchanting. Finally, Kafka read her a letter of the story that brought the doll back to Berlin, and he then gave her a doll he had purchased. "This does not look at all my doll," she said. Kafka handed her another letter that explained, "My trips, they have changed me." The girl hugged the new doll and took it home with her. A year later, Kafka died.

Many years later, the now grown-up girl found a letter tucked into an unnoticed crevice in the doll. The tiny letter, signed by Kafka, said, "Everything you love is very likely to be lost, but in the end, love will return in a different way."

We all have opportunities in life where we have the choice to make a difference by our words and actions. Especially during this holiday season, may we all choose to be loving and kind.



12 Months of Reflections for People in Recovery

January 15, 2024

Quote of the Week "Those who laugh—last."

I remember hearing the phrase "We are not a glum lot" when I was new in recovery. But I didn't believe it. I mean, here I was sentenced to attend meetings, prohibited from partying, and forced to develop a faith in God. Things looked pretty glum to me. If it wasn't for the laughter I heard in the rooms, I may not have stuck around.

At first, I couldn't understand what they found so funny. People would share embarrassing, demoralizing, and even tragic experiences, and the room would burst into laughter. Some of the things they shared I wouldn't even admit to myself. "I don't get it," I finally said to my sponsor. "Those who can laugh at themselves tend to last," he told me. It took a while, but I sure did find that to be true.

One of the most valuable lessons I've learned in recovery is not to take myself so seriously. Once I cleared away the wreckage of my past, I was free. Today, I allow myself to make mistakes, and if I step on someone's toes, I'm quick to make amends. Because of this, my life is lighter today, and I find it easy to laugh at myself. This not only makes the journey more enjoyable, but it's what's made it last so long, too.

"...a wonderful thing had happened. The head promoter wrote the Foundation office. He said he wished he'd paid some attention to A.A. experience. Then he did something else that was to become an A.A. classic. It all went on a little card about golf-score size. The cover read: "Middleton Group #1. Rule # 62." Once the card was unfolded, a single pungent sentence leaped to the eye:

"Don't take yourself so damn seriously!"

At this juncture, his A.A. sponsor usually laughs. TWELVE STEPS AND TWELVE TRADITIONS, p. 26

Before my recovery from alcoholism began, laughter was one of the most painful sounds I knew. I never laughed and I felt that anyone else's laughter was directed at me! My self-pity and anger denied me the simplest of pleasures or lightness of heart. By the end of my drinking not even alcohol could provoke a drunken giggle in me.

When my A.A. sponsor began to laugh and point out my self-pity and ego-feeding deceptions, I was annoyed and hurt, but it taught me to lighten up and focus on my recovery. I soon learned to laugh at myself and eventually I taught those I sponsor to laugh also. Every day I ask God to help me stop taking myself too seriously.

WHY IS THE TRIANGLE THE SYMBOL OF AA?

S YMBOLISM is a very important tool in the field of communications today. Almost every corporation, business enterprise or service organization is trying to project a symbol—a visual "image" of itself

For example, the Rock of Gibraltar is the symbol of the Prudential Life Insurance Company. The bell is the symbol of the Telephone Company. A red cross on a white background is the symbol of the American Red Cross, and so on. If you stop to think about it, I

believe you will agree that AA too has a symbol: the triangle.

The 1955 Conference in St. Louis adopted the triangle as AA's symbol of Recovery, Unity and Service. The base of the triangle represents our First Legacy — The Twelve Steps of Recovery. The left arm of the triangle represents our Second Legacy—The Twelve Traditions. And the right arm of the triangle represents our Third Legacy of Service. The official trademark of AA Publishing Company literature is the triangle within a circle which represents the world.

Symbolism doesn't just happen. There is usually a reason for its existence. If we go back to the days before AA we find our very first triangle. Here Ebby T. suggests a novel idea to Bill W. His idea is that perhaps one alcoholic might be able to stay sober by working with another alcoholic. Bill W. thought about this and discussed it with Dr. Silkworth, the little doctor who loved drunks. Then Bill W. went out to Akron and met Dr. Bob. They teamed up together to make their first AA call on Bill D., "the man on the bed" in the Akron hospital. Thus, the first human triangle consisting of Bill W., Dr. Bob and Bill D. was formed.

Just stop to think about the symbolism of the triangle for a moment and what this means to you and me. The chances are that when you came into AA you had a sponsor. Chances are that since becoming sober you have helped to sponsor someone else. So here is your very own living triangle: your sponsor, you and your "pigeon."

It is easy to understand how AA works when you think of yourself as the base of your own triangle, supported on one side by your sponsor, and helping to support your pigeon on the other side. Perhaps you are the base of a dozen or more triangles.

As a sober alcoholic I am grateful to be an integral part of my own personal triangle. I am also grateful that my personal triangle draws upon the strength of many thousands of triangles—all joined firmly together among the 250,000 members of AA who belong to some 7,000 groups all over the world.

The North American groups elect eighty-three delegates to represent them each year at AA's annual General Service Conference. So we have another triangle consisting of 250,000 members, several thousand group representatives and the eighty-three Delegates to the Conference.

Also represented at the General Service Conference is still another triangle of about 100 people. The eighty-three Delegates form its base. The six staff members of the General Service office, plus two Directors of the AA Publishing Company and two Directors of the Grapevine plus Bill W. and Hank G. are the second arm of the triangle. The third arm is represented by the fifteen members of the Board of Trustees.

The triangle is, then—in many ways—the symbol of AA. And the delightful part of it all is that every time a sick new member comes into AA he or she immediately joins hands with two other members who lend their strength in helping him or her to succeed in our program of Recovery, Unity and Service.


A.A. World Services, Inc. and AA Grapevine, Inc. have registered a number of trademarks and logos, and the guidelines for using them are based partly on legal considerations and partly on the nature of A.A.


Use of these marks on goods or services that do not emanate from A.A., and have not been approved by A.A., both infringes upon and dilutes A.A. marks, in legal terms. The resulting harm is that the marks and A.A. itself, since A.A. is what the marks symbolize, will come to be associated with a variety of products and services that are not part of A.A., and are not consistent with A.A.'s purpose. This will cause the marks to lose their meaning and significance as symbols of Alcoholics Anonymous. In 1993, Alcoholics Anonymous World Services, Inc. announced that official use of all of the several circle/ triangle trademarks and service marks was being discontinued.

Substantially all of the publications and other material produced and distributed by A.A.W.S. and Grapevine, including service material, are protected by copyrights that have been registered by the respective corporations. These materials are valuable Fellowship assets and are held for the benefit of A.A. as a whole. Therefore, the reprinting and/or copying of these materials is carefully monitored by A.A.W.S. and Grapevine in order to avoid any erosion or loss of the copyrights.
